### Code of Ethics

- I will evidence a genuine interest in all persons served and do hereby dedicate myself to their best interests.
- I will maintain a professional attitude that upholds confidentiality and respect towards the individuals served, other volunteers, applicants, staff, and the non-profit.
- I will not engage in or condone any form of harassment or discrimination.
- I will accurately represent my education, training, experience, and competencies as they relate to volunteer with Churches United.
- I will not steal or misuse Churches United property.
- I will not purchase items for guests using my personal funds.
- I understand that violation of the code may be grounds for dismissal as a volunteer.

### **Attendance**

We understand that life happens. If you are not able to attend your scheduled shift, please let your site supervisor or the Volunteer Coordinator know no later than two hours before your scheduled shift. You can always reschedule for another day! Our volunteer opportunities will be here when you are ready to come back.

# Confidentiality

- The relationship between professional staff, volunteers, and clients is strictly confidential.
- Under no circumstances is the business, medical affairs, or identity of clients at Churches United to be discussed with any outside party without the specific written permission of the client or by order of the court.
- Who is seen here stays here, but feel free to share your experiences as long as any personal information or identifying factors can be excluded.
- If confidentiality is breached, dismissal of the volunteer will occur.

# **Boundaries & Safety**

- Do not designate any gifts to specific residents (money, clothing, food, etc.). If you wish to donate to the organization, please feel free to do so - donated dollars can even be designated toward a specific program. Individual gifts can show favoritism.
- Do not exchange personal information (addresses, emails, phone numbers, etc.) or offer rides to consumers of Churches United services without first discussing it with the Volunteer Coordinator.
- Children under the age of 18 need a chaperone.
   Groups of youth should have one adult per six children.

# Discipline Procedure

- 1. A reminder and verbal warning by the Volunteer Coordinator will be issued, which is then documented in the volunteer's file.
- 2. A written warning and correction place will be issued and documented in the volunteer's file.
- 3. A one (1) month suspension from volunteering at Churches United will be issues and documented in the volunteer's file.
- 4. The volunteer will no longer be eligible for volunteer service at Churches United.

We reserve the right to terminate any volunteer service from any individual or group based on the needs of the organization.

# **Liability Release**

I hereby release, indemnify, and hold harmless Churches United, the agencies, organizers, sponsors, and supervisors of all its activities from any and all liability in connection with any injury (including injury caused by negligence) received in conjunction with Churches United. I also hold harmless from liability any person transporting me to or from any Churches United activity.

### Media Release

I hereby give my consent to Churches United to photograph and then use, reproduce, and publish said images of me and/or my child/children.

I agree that photographs/negatives, thereof shall constitute the sole property of Churches United with full right of disposition in any manner whatsoever, including the right to publish where needed.

I hereby release Churches United and their legal representatives and assigns from all claims whatsoever about the use, production, publication of the images thereof.

This release can be revoked upon written request of person signing the document at which time all the photos, negatives will halt being used to the best of our knowledge or ability; otherwise it will remain in effect for five (5) years from the date of the signed document. All signed releases will be available upon request from the Human Resources Office Administrator at Churches United.

# Company Vehicle Use

Volunteers are allowed utilization of Churches United vehicles if the following criteria are met:

- Vehicles will travel no more than 25 miles from 1901
   1st Ave N, Moorhead, MN.
- Vehicles are used no more than twice a week.
   Sundays being the exception.
- The vehicle must be scheduled a week in advance on a week by week basis.
- Vehicle must be checked out and checked back in on the same day.
- Use of vehicle will not conflict with staff usage.
- Mileage will be documented and tracked on the appropriate ledger.
- Those being transported must have a Transport
   Liability Release Agreement signed both with
   Churches United and the organization the volunteer
   is transporting for.
- All drivers need to have a copy of their license and insurance information documented with Churches United.
- If the vehicle does break down, volunteers must contact the shelter and appropriate shelter staff first.
